- 1. Judge Ed Smith called the meeting to order noted the presence of a quorum; County Judge led the group in the Pledge of Allegiance with Commissioner Williams providing the opening prayer.
- 2. Review of minutes August 8, 2022 Commissioner Williams made a motion to accept as presented. Commission Garren provided the second. Motion carried 5-0.
