
7. County Judge's Report.

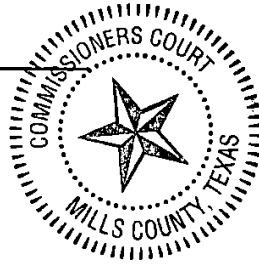
