Motion made by Commissioner Mike Wright to approve new members for Mills County Child Welfare Board and second Commissioner Dale Partin. Carried 5-0.


9. Consider Act on Courthouse Christmas lights.

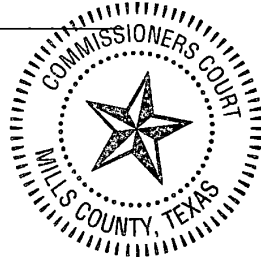
