- 1 The Opening pledge of Allegiance was led by Judge Johnson and Prayer was provided by Commissioner Williams
- 2 Review and Act on Minutes of April 14, 2025, and Workshop Minutes of April 14,2025 Commissioner Williams made the motion to accept the minutes as submitted, Commissioner Head the 2nd motion Carried 5-0
- 3 Audience with Individuals, There was no one who signed up to speak
- 4 Consider and Act on approving accounts payable There was one question regarding a charge at John Deere House Commissioner Partin stated that it was his charge but showed up on Commissioner Sullivan's account With that noted Commissioner Head made the motion to approve Accounts Payable and Commissioner Sullivan provided the second Carried 5-0
- 5 Consider and Act on approving Investment Policy, and related matters The Investment Resolution will read the same as it has in the past Judge Johnson made the motion to approve the Resolution and Commissioner Head provided the second Carried 5-0
