This Regular Meeting session of the Mills County Commissioners Court opened in due form of law at 9 a.m. in the Mills County Commissioners' Courtroom located at 1011 4th Street, Goldthwaite, Texas 76844.

 Judge Jett Johnson called the meeting to order noting the presence of a quorum. Judge Jett Johnson led the Pledge of Allegiance with Commissioner Williams providing the opening prayer.

 Motion made to approve Accounts payable by Commissioner Jason Williams and seconded by Commissioner Robert Head. Carried 4-0.

Motion made to Joint Election Agreement with Priddy ISD, by Jett Johnson and seconded by Dale Partin. Carried 4-0.

6. Consider and Act on Approving 2025 Sheriff's and Constable's fee schedule.

Sheriff Anthony Poole said that the fees are in line with all surrounding counties.

Motion made to approve the 2025 Sheriff's and Constable's fee schedule by County Judge Jett Johnson approved and seconded Commissioner Robert Head. Carried 4-0

8. Consider and Act on Hamilton EMS budget
Present is Patrick Cobb - Chief HEMS on EMS Interlocal Agreement from audit view.

See Letter from package recorded in minutes.

Present is Patrick Cobb – Chief HEMS on EMS Interlocal Agreement spoke about the latest audit financial 2023 review. Mills County and San Saba County pays \$250,000 for ambulance services and share in a 3rd ambulance. Mills County \$39,000 above margin and San Saba County \$202,000 below margin. Between the two counties, the deficit is \$170,000. The reason for this is the 3rd Ambulance you share with San Saba all expense was to San Saba 6 employees + 3 supervisors. Both Judges from Mills and San Saba have had numerous meetings to come up with the split of the deficit. If agreed by the court, the Judge proposes a motion based this on call volume. 39% of calls are answered from the 3rd truck. If there is no change in funding, then the 3rd truck will have to go away. This will be detrimental to the citizens of the Counties. With the percentage of call volume, the new base cost will be \$363, 425.00 Mills County and San Saba County roughly \$23,000 more on their part based on call volume. Next year will be spilt 50/50. Commissioner Dale Partin asked didn't we just renewed the contact last year. Patrick Cobb response was 5-year contact auto renewed; the length of the contact 4 year doesn't have to act. This is the first year with a deficit. Commissioner Jason Williams and Dale Partin asked is this going to be a one-time deal or will remain coming back each year. Patrick doesn't

see prices going down for the services. The contract has in policy for differential changes in the economic pressure, market it pressure keeps going up. For the last 3 years with COVID and changes. Due to expenses going up and several changes in Medicare ERISA. We must publish our rates in the contract. Medicare will have to be reimbursed. To add the appendix to contact with the court approval. When is San Saba meeting on these this issue. Judge Fauley will have on there agenda probably in July. Motion made for on the base call volume to approve the new budget for EMS Mills County share \$363,425.00. This will go into effect Oct 1. Seconded by Commissioner Jason Williams and Commissioner Dale Partin and Commissioner Robert Head against. Vote-2-2. Motion failed. Put on next agenda.

Consider and Act on Mills Central Appraisal District budget.

Motion made by to approved MCAD budget County Judge Jett Johnson and seconded by none. Motion dies. Commissioner Jason Williams wants to see what other counties are going to do. Wait, look at this later to see what other entities do. Readdress this. Motion failed.

 We had a workshop at the Law Enforcement Center with approximately 25 people. With 4 people from TDEM and Cohn Reznick two from . Addressed many many topics. Comments by Jason Williams FEMA's grant is going to be a lot of work. Once we get going. I think we will be alright. The essential going to be hard for us precincts getting the documentation when we haven't been doing it. To hire someone or go through a group to help us with the FEMA's grant assistants. It's going to be a tremendous workload on Treasurer Office or EMC. Brief talk with Sheriff Poole and Sheriff Elect Jones too and their plate is full. Hollee Ragsdale Next step is to send in application for the help from request for public assistants is due Aug 9, 2024. EMC Emergency Manager has not been one for the County. Former Sheriff Clint Hammonds was now appointed Sheriff Poole. Reimbursement to the County for a employment of a person to do process. Hollee opinion is to put in RPA by 8/9. Who the court put in now so that can be set up with all log in. All 5 were there for the application briefing. Motion by to start process Commissioner Dale Partin and seconded Commissioner Jason Williams, Carried by 4-0.
