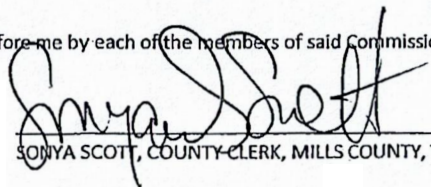


DALE PARTIN
