

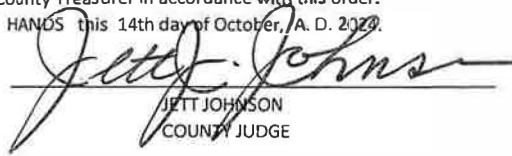
**IN THE MATTER OF THE QUARTERLY REPORT OF

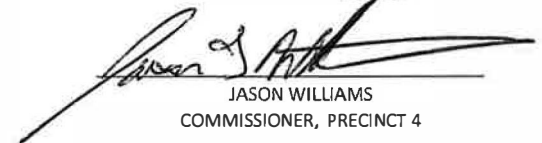

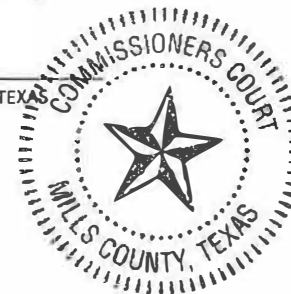
