Mills County is accepting bids for Material Aggregate for County Roads;

- #1 CRUSHED ROAD BASE 2/4" OR SMALLER
- #2 CRUSHED ROAD BASE 2" OR SMALLER
- #3 PIT RUN BASE/ CALICHE
- #4 SCREENED ROAD BASE 3" OR SMALLER

ALL MATERIALS will be bid under the following terms and conditions:

Bid unit shall be by the ton or cubic yard at the bidder's preference. Bids may include the loading of County trucks at your location. The bidder may submit a separate price if the County loads our own trucks using our loader. Bidders may also bid the material and delivery to the County Material Stockpiles.

PIT RUN BASE may be bid as stockpiled price or as a price of material to be dug and processed by County Employees.

In determining the lowest and best bid for road material, the Commissioner's Court may consider the location of material and the cost of hauling material to the work location. The Commissioner's Court may award the contract for the purchase of road construction material to more than one bidder if each selected bidder submits the lowest and best bid for a particular location.

All accepted bids will go into effect on December 8, 2025, and continue until September 30, 2026.

Mills County has Bid Forms available. We prefer that you use the BID Forms, but it is not required. Bid Forms can be emailed or faxed to you. Please call Mills County Judges office (325) 648-2222 or email [countyjudge@millscountytexas.gov](mailto:countyjudge@millscountytexas.gov) to receive Bid Forms. Bids should be submitted to the Mills County Judge's Office, 1011 4th Street, Goldthwaite Texas 76844 by 12:00pm on December 1, 2025. Bids should be sealed and marked "Mills County Crushed Rock Bid" and the number of the material that you are bidding on. Bids must include Item Number, Name of Material, and your bid for the price of Material.

Bids will be opened on December 8, 2025, in the County Courtroom during Commissioner's Court.

Mills County reserves the right to reject any and all bids.
